York Theatre Royal Membership Terms and Conditions

Direct Debit and cancellation periods

Act 2 upwards, members are able to pay for their membership in monthly instalments. On renewal, you will be notified at least 10 working days in advance of your account being debited. Existing memberships will carry on paying the original amount until the renewal date, when the new payment levels will be charged.

York Citizens' Theatre Trust will notify you at least 10 workings in advance of your account being debited or as otherwise agreed if amounts to be paid or the payment date changes.

Membership benefits

York Theatre Royal reserve the right to change any of package benefits at any time to maintain the sustainability of the membership. Due to the nature of many of the events and receptions outlined in the benefits, notice for events may vary across the year and dates and times may change. We aim to notify you of any changes as soon as we can and no later than 48 hours before the event.

Communications

News, event invites, notification of priority booking periods and updates will be sent via email, please provide an email address when joining. Make sure you have not opted out of postal and email communications with us to be the first to know and not miss out on your benefits and event invitations. Priority booking

Priority booking gives an extended notice period before tickets go on general sale to the public. Restrictions may apply.

Free ticket exchange

Tickets can be exchanged for another performance of the same show provided this is done 48 hours prior to the performance you were due to attend. If you already have your tickets they will need to be returned to Box Office in order to exchange.

Season launch invites

These events are organised around the York Theatre Royal programming schedules and we aim to give as much notice as possible. Due to the nature of associated parties details of the events may be subject to change.

Ticket discounts

All members are eligible for an extra 5% discount on top of Season Ticket discounts.

From Act 2 upwards, members are eligible for a 5% discount off an unlimited number of tickets (all single/individual tickets as well as the 5% discount on top of the Season Ticket package) all year round. Act 2 members upwards get an extra 5% (equal to 10%) off all tickets (single and Season Tickets) during their priority booking period. Restrictions may apply on fundraising events, events in the De Grey Rooms or visiting company productions.

An opportunity to name a seat will be available to you after payment of your first contribution (Benefactor only) and is valid for 10 years. Text to be agreed with the Development Team.
